Dear Crown Prosecution Service Inspectorate,

Firstly many thanks for your reply to me dated 20th December in response to my Freedom of Information Request as per the attached PDF Copy.

You state that you do not have any of the documents that I request, I would therefore suggest & request that you **FULLY INVESTIGATE** why the Crown Prosecution Service (who must have such documents on file) **FAILED** on numerous occasions to disclose the contents of such to either myself or indeed any of the numerous other victims of Fake Sheikh Mazher Mahmood from 1994 onwards up to the present day.

I would request that you fully Investigate & explain to me why the Police and Crown Prosecution Service **FAILED MASSIVELY** in their Disclosure duties to me (**back in 1998/1999**) and also to all other Mazher Mahmood Victims since 1994 given that the CPS and Police (**as illustrated by details in my Grounds of Appeal that are on www.circusofthemind.net**) both knew and communicated with each other in Circa 94/95 stating then that Mahmood Could **NOT** and Should **NOT** be relied upon as a witness of truth in any further cases.

It has also now come to my attention that numerous other cases were dropped (or lost) over the years by the CPS involving Mazher Mahmood and yet none of the details of any of these were ever disclosed to myself and/or the many other "Fake Sheikh" Victims over the years of 1994 to present day.

I further would ask you to investigate fully why in 2014 when the Tulisa Contostavlos Trial collapsed and "Disclosure packs" were sent out to past victims such as myself, why the CPS did not take this another opportunity to put things right by also disclosing to us the knowledge they most certainly did have of the case collapsing in 1994/1995 due to Mahmoods Dishonesty being called into question and other cases that also either collapsed and/or the CPS lost over the years since then.

(Remember News Group Newspaper = NGN have in their files as disclosed during the Phone Hacking High Court Cases and mentioned in my grounds of appeal shown on www.circusofthemind.net documents relating to 94/95 and the collapse of a trial which show the CPS and Police communicating with each other and stating that they could NOT and should NOT consider Mazher Mahmood a witness of truth any longer.)

I have to ask you to investigate and explain why when this was stated in 1994/1995 did the CPS continue to reply on his evidence in cases and why was the events of 94/95 and also subsequent cases/trials that collapsed and/or were lost by CPS not disclosed to myself in 1998/1999 in relation to my case or indeed to any other of the many victims of Mazher Mahmood?
